ORDER TO SHOW CAUSE

Upon the affirmations of Christine Cardi, Associate General Counsel of the Department of Financial Services, dated August 9, 2016, and William J. Snipes, counsel for the Superintendent of Financial Services of the State of New York (the "Superintendent") in the Superintendent's capacity as receiver of the New York-licensed agencies of Jugobanka A.D., Beograd and Beogradska Banka A.D., Beograd, dated August 11, 2016, together with the exhibits thereto, it is hereby

ORDERED, that any party having interest in this matter appear at a hearing at IAS Part 53 of this Court, to be held in and for the County of New York, 60 Centre Street, New York, New York, to be held on the ~~16th~~ ^{15th} day of ~~August~~ ^{Sept.}, 2016 at 11:00 a.m., or as soon thereafter as counsel can be heard, and show cause why an


order, pursuant to New York Banking Law ("NYBL") §§ 606, 613, and 627, should not be entered:

- (a) granting the Superintendent final approval of payment of expenses incurred in administering the agencies' liquidations during the period July 1, 2010 through August 31, 2016;
- (b) authorizing the Superintendent to dispose of the agencies' books and records that are in his possession;
- (c) authorizing the Superintendent to pay out of the agencies' liquidation estates a dividend to each creditor whose claim or accounts payable has been accepted or otherwise duly established;
- (d) authorizing the Superintendent to pay out of the agencies' liquidation estates incidental expenses incurred in complying with the terms of this Order; and
- (e) upon completion of the foregoing steps (a) – (d), declaring the agencies *ipso facto* dissolved and their existence terminated.

ORDERED, that all opposing papers be served on or before the 5th day of

Sept, 2016; and it is further

ORDERED, pursuant to NYBL § 613, that notice in the form attached

 hereto as Exhibit A be published once each week for two consecutive weeks in the *New York Times* during the weeks of ~~Sept 2~~^{Sept 6} 2016 and ~~Sept 9~~^{Sept 13} 2016.
